Amending The Memorandum Of Agreement Between City Of Albuquerque Parks And Recreation And New Mexico Department Of Agriculture In Fiscal Year 2021 (Gibson, by request)

AMENDING THE ATTACHED MEMORANDUM OF AGREEMENT BETWEEN CITY OF
ALBUQUERQUE PARKS AND RECREATION AND NEW MEXICO DEPARTMENT OF

AGRICULTURE IN FISCAL YEAR 2021.

WHEREAS, the Grant Funds appropriation in Section 2. of R-2021-049 was to be appropriated to the Parks and Recreation Department in the 110 Fund for Fiscal Year 2021 in the amount of \$20,000 and are available to the City of Albuquerque from the New Mexico Department of Agriculture; and

WHEREAS, the appropriation in Section 2. of R-2021-049 requires an update to the appropriation to 265 Fund; and

WHEREAS, the Fiscal Year 2020 in Section 2. of R-2021-049 requires an update to Fiscal Year 2021 to the Resolution document submitted.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. That the appropriation is hereby changed from Parks and Recreation Department in the General Fund (110) for Fiscal Year 2020 to the Operating Grants Fund (265) for Fiscal Year 2021.
