RESOLUTION

Approving And Authorizing The Acceptance Of Grant Funds From The Dennis Friends Foundation And Providing An Appropriation To The City Of Albuquerque Animal Welfare Department In Fiscal Year 2022 (Gibson)

APPROVING AND AUTHORIZING THE ACCEPTANCE OF GRANT FUNDS FROM THE DENNIS FRIENDS FOUNDATION AND PROVIDING AN APPROPRIATION TO THE CITY OF ALBUQUERQUE ANIMAL WELFARE DEPARTMENT IN FISCAL YEAR 2022.

WHEREAS, one of the goals of the City of Albuquerque is to bring awareness and to provide affordable to no cost support to City residents with pet sterilization, microchip identification and vaccinations for their companion animals; and

WHEREAS, The Dennis Friends Foundation wishes to award the City of Albuquerque Animal Welfare Department in support of AWD programs and the new clinic; and

WHEREAS, the City of Albuquerque Animal Welfare Department will utilize the \$300,000 grant funds to purchase equipment and supplies needed for the AWD New Clinic; and

WHEREAS, the City of Albuquerque desires to appropriate these funds to the AWD New Clinic in FY 2022 which requires no City match or indirect overhead.

BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF ALBUQUERQUE:

Section 1. That the attached grant award from Dennis Friends Foundation is hereby approved, and its acceptance and filing with the appropriate official or office is and in all respects approved.

Section 2. That funds in the amount of \$300,000 from Dennis Friends Foundation are hereby appropriated in fund 265 to the City of Albuquerque Animal Welfare Department for Fiscal Year 2022.
