She helped develop 38 acres into a multigenerational recreation center (Eagle Park) for the City of Belen, collaborated on establishing the Whitfield Bird Refuge in Valencia County, and the City of Belen Community Garden. She currently teaches an exercise class, "Aging Well," which she developed for the Santa Ana Pueblo, Tamaya Wellness Center. The skill sets she has to offer to the Senior Affairs Advisory Council are the following: A holistic view of how to create a resilient community for seniors and their particular needs; organization skills to strategically asses, plan, and evaluate what is needed to assist our seniors; and, a passion to make our community a better place for all.
