Extensive experience in veterinary clinics taught Lindsey the deep healing power of rescue dogs which translated into a one-of-a-kind curriculum, utilizing mental health treatment plans, education, and case management to transform the lives of veterans and shelter dogs. Lindsey has seen hundreds of individuals, both veterans and their family members, receive services from Paws and Stripes.
