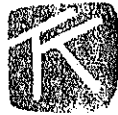

A resident of Council District 8, Mr. Daniel C. Martinez will fill a vacancy and serve as an At Large Representative; their first term will expire on April 18, 2028.


