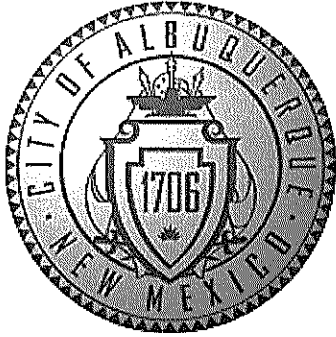


This legislation amends the Appendix: Collection and Disposal Rates of the Municipal Solid Waste Ordinance to establish higher Convenience Center fees for non-Albuquerque users, both residential and commercial. Rates for Albuquerque residents and for business located within Albuquerque city limits remain the same, at \$5 plus tax per load and an additional \$5.54 for an uncovered and/or unsecured load. A new rate of \$12 plus tax per load is established for residential loads of individuals who reside outside of city limits, for businesses located outside of city limits, and for the additional fee on an uncovered and/or unsecured load.

Cover Analysis

- 1. What is it?** This is legislation to amend the Municipal Solid Waste Ordinance.
- 2. What will this piece of legislation do?** This legislation amends the Appendix: Collection and Disposal Rates of the Municipal Solid Waste Ordinance to establish higher Convenience Center fees for non-Albuquerque users, both residential and commercial. Rates for Albuquerque residents and for business located within Albuquerque city limits remain the same, at \$5 plus tax per load and an additional \$5.54 for an uncovered and/or unsecured load. A new rate of \$12 per load is established for residential loads of individuals who reside outside of city limits, for businesses located outside of city limits, and for the additional fee on an uncovered and/or unsecured load.
- 3. Why is this project needed?** It ensures that services used by non-residents are more accurately aligned with their true cost, protecting resources funded by Albuquerque taxpayers and preventing any increases to Albuquerque residents.
- 4. How much will it cost and what is the funding source?** N/A
- 5. Is there a revenue source associated with this contract? If so, what level of income is projected?** Surcharge revenue will be generated at an estimated \$1.1 million in the Refuse Disposal Operating Fund and held in reserve to be appropriated at a future date.
- 6. What will happen if the project is not approved?** The Convenience Center rates will be unchanged and no new revenue will be generated.
