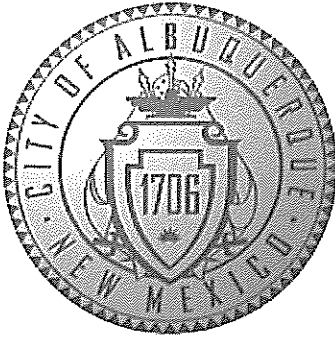

Dr. Joseph P. Sanchez is State Director for AARP New Mexico. He previously spent nine years leading government and public relations for the UNM College of Nursing, and served as Executive Director of the New Mexico Center for Nursing Excellence, working with AARP's Center to Champion Nursing and the Robert Wood Johnson Foundation. Earlier, he spent nearly 13 years as a program director at the New Mexico Public Education Department.

He is a U.S. Navy veteran and retired at the rank of Commander. He holds a Ph.D. in Human Development and Family Studies from UNM and a Master's and Bachelor's in Business Administration from New Mexico Highlands University, along with certifications in Naval Integrated Logistics, change management (Prosci), and leading change (Vanderbilt's Owen Graduate School of Management). He is a graduate of Leadership Albuquerque (2022), the Ignite Latino Leadership Institute (2024), and Leadership New Mexico's Core Program (2025).

A resident of Council District 9, Dr. Joseph P. Sanchez will continue to serve as an At Large representative on the council; their first term will expire July 31, 2029.
