Michelle McMullan is a nonprofit leader and social services professional with more than a decade of experience in care coordination, case management, and community advocacy in Albuquerque. She currently serves as Director of Care Services at ALS New Mexico, a fully local nonprofit she helped establish following its separation from the national ALS Association in 2023, where she manages support programs, clinic liaison work at UNM Hospital, and state and federal advocacy.

Earlier in her career she worked as a Family Intervention Specialist at PB&J Family Services and as a substance abuse counselor and lead counselor at HealthQwest-Frontiers in Georgia. She holds a Bachelor of Science in Psychology from Georgia College and State University. Michelle has been deeply involved in civic life since moving to New Mexico, serving as President of the Junior League of Albuquerque and currently as President and Board Member of the Independent Living Resource Center.

Though originally from out of state, she has called Albuquerque home for nearly 12 years and has found in New Mexico a community defined by its care for one another. She is eager to bring her professional experience and community connections to the board in service of that commitment.

A resident of Council District 7, Michelle Debele Waters McMullan will fill a vacancy and serve as an At Large Representative; their first term will expire on April 18, 2029.
