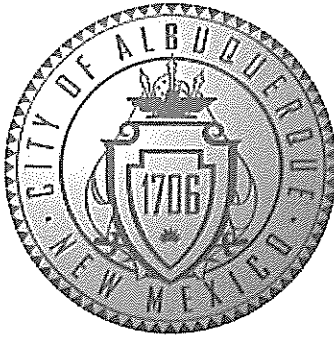

Linda Morgan Davis is a retired librarian, grant writer, and administrator with more than 40 years of experience in the public and private sectors. She retired from The Public Library Albuquerque Bernalillo County in 2019 after a distinguished career in public service. Through her work with the library system, she developed extensive knowledge of City operations and collaborated with the Albuquerque Museum Foundation to establish the Museum Pass program, expanding free public access to the Museum through local libraries.

Linda is seeking appointment to the Albuquerque Museum Board of Trustees to help strengthen the Museum's visibility, community partnerships, and long term financial support. She hopes to use her experience in public service, grant writing, and community engagement to advocate for funding and resources that will ensure the Museum continues to serve Albuquerque residents and visitors for generations to come.

A resident of Council District 1, Linda Morgan Davis will fill a vacant seat as the Council District 1 representative on the board; her first term will expire on July 31, 2029.
