1 RESOLUTION

2 ESTABLISHING THE CITY'S INFRASTRUCTURE CAPITAL IMPROVEMENTS
3 PLAN (ICIP) PRIORITIES FOR 2026.

4 WHEREAS, the City of Albuquerque's Infrastructure Capital Improvement
5 Plan ("ICIP") is a comprehensive, multi-year strategic plan designed to
6 identify, prioritize, and fund critical capital projects aimed at maintaining,
7 modernizing, and expanding the City's essential infrastructure and public
8 facilities; and

9 WHEREAS, the Administration and City Council have worked together to
10 make critical capital investments for communities across the City; and

11 WHEREAS, community members are experiencing housing insecurity and
12 rising rental costs, increasing the need for more affordable, transitional, and
13 supportive housing and investments in our homeless facilities to help foster
14 stability, dignity, and equitable access to safe living environments; and

15 WHEREAS, modern public safety challenges require robust and responsive
16 measures, including enhancing technology, equipment and facilities to
17 improve emergency response, protect lives, and ensure that Albuquerque
18 Community Safety, Albuquerque Fire Rescue and the Albuquerque Police
19 Department are equipped to meet the evolving needs of the community; and

20 WHEREAS, revitalizing urban areas through strategic projects like the Rail
21 Trail, not only stimulates economic growth and contributes to placemaking, it
22 enhances connectivity by linking neighborhoods which strengthens our
23 communities; and

24 WHEREAS, investments in energy efficiency and climate resilient
25 infrastructure will mitigate environmental effects, reduce operational costs,
26 and ensure long-term sustainability and safety for all residents; and

1 WHEREAS, in 2025, O-25-98 and R-25-196 passed unanimously by the City
2 Council and signed by the Mayor, improving on protections for vulnerable
3 road uses across the City; and

4 WHEREAS, along with the implementation of these crucial pieces of
5 legislation, continued targeted infrastructure investments through our Vision
6 Zero program will continue to promote safer environments that connect
7 people to places securely.

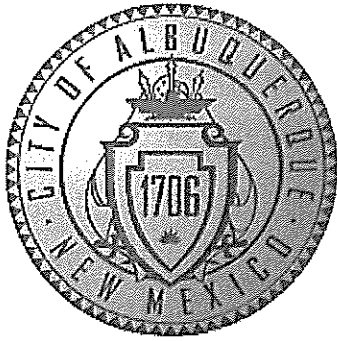
8 BE IT RESOLVED BY THE COUNCIL, THE GOVERNING BODY OF THE CITY OF
9 ALBUQUERQUE:

10 SECTION 1. The City of Albuquerque has identified five key areas as the
11 priorities of its Infrastructure Capital Improvement Plan ("ICIP") for 2026 and
12 are as follows:

- 13 1. Affordable, Transitional, and Supportive Housing and Homeless
14 Facilities.
- 15 2. Public Safety Technology, Equipment and Facilities.
- 16 3. Economic Growth and Placemaking through Continued Development of
17 the Rail Trail.
- 18 4. Energy Efficiency and Climate Resilient Infrastructure.
- 19 5. Protecting Vulnerable Road Users through Vision Zero Investments.

20 SECTION 2. SEVERABILITY CLAUSE. If any section, paragraph, sentence,
21 clause, word, or phrase of this Resolution is for any reason held to be invalid
22 or unenforceable by any court of competent jurisdiction, such decision shall
23 not affect the validity of the remaining provisions of this Resolution. The
24 Council hereby declares that it would have passed this Resolution and each
25 section, paragraph, sentence, clause, word, or phrase thereof irrespective of
26 any provision being declared unconstitutional or otherwise invalid.

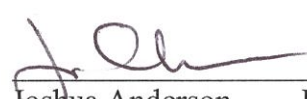
