Andrea Lima is a primary care nurse practitioner at the Raymond G. Murphy VA Medical Center, where she leads a top-ranked patient care team. She and her husband relocated to Albuquerque in 2021, drawn in part by the city's bike-friendliness. Cycling is a family activity for the Limas — much of its draw is time outdoors and in nature, along with better health and a smaller carbon footprint. After three and a half years of building the confidence to ride the city alone, she now bikes to work as well. Andrea volunteers with One Albuquerque and previously served as secretary of Street Access for Everyone (SAFE), a 501(c)(3) in North Carolina's Lake Norman area that advocates for cyclist and pedestrian safety. As an active cyclist, she sees both the benefits of riding and the opportunities for improvement, and wants to share her experience and perspective to make cycling safer and more viable for more people in Albuquerque.

A resident of Council District 9, Ms. Andrea Estelle Lima will fill a vacancy and serve as a Off-Road Bicyclist Representative on the Committee; their first term will expire on June 30, 2029.
